With the summer's end comes the start of school, so many kids will be hopping on school buses once again. If your children are one of the many riding the school bus, be sure to reiterate how to stay safe, because a bus accident can mean multiple injuries.

Make sure children know to remain in their seats when the bus is in motion. Talk about the importance of keeping their head, arms, and hands inside the bus (not

out of the windows). Outside, children should cross only in front of the bus (10 feet ahead is the recommendation) and always make eye contact with the driver before stepping in front of the bus to cross the street.

Drivers need to be vigilant too. Obey all speed limits in school zones and if a bus is stopped with the stop sign out, don't go around the bus. By law, drivers are required to stop and wait in all directions so children getting on and off the bus can do so safely.

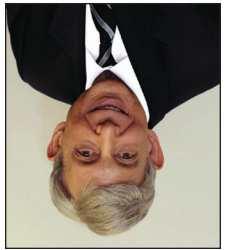
