### IN PERSONAL INJURY CLAIMS, WHAT COUNTS IS THE VALUE OF YOUR TIME, REGARDLESS OF WHETHER YOU HAVE SICK/ ANNUAL LEAVE OR NO "LEAVE" TIME AT ALL

In a personal injury case, an employee who is injured by a negligent act outside of the workplace may recover money for the value of lost time when there is documentary proof of the time loss from the employer, even if he or she received sick or annual leave and there is no actual pay loss. For periods of time longer than a few days following the accident date, a doctor's note is required to persuade an automobile liability insurer to pay such a claim.



Once the loss wage is documented, the effect of this claim on the settlement amount or court verdict means much more than just the lost wage amount. Recently, a Maryland court considered the claims of two injured people injured in the same collision whose medical bills were nearly identical as well as the nature of their injuries. However, the court awarded substantially more money to the person who proved lost wages than the person who did not present a lost wage claim.
